



DUTY FREE & TRAVEL RETAIL SALES 2016 BY CATEGORY (US\$bn)





DUTY FREE & TRAVEL RETAIL SALES 2016 BY REGION (US\$bn)







DUTY FREE & TRAVEL RETAIL SALES Q1 2017 BY REGION (US\$bn)










