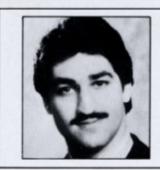


MEMBERS

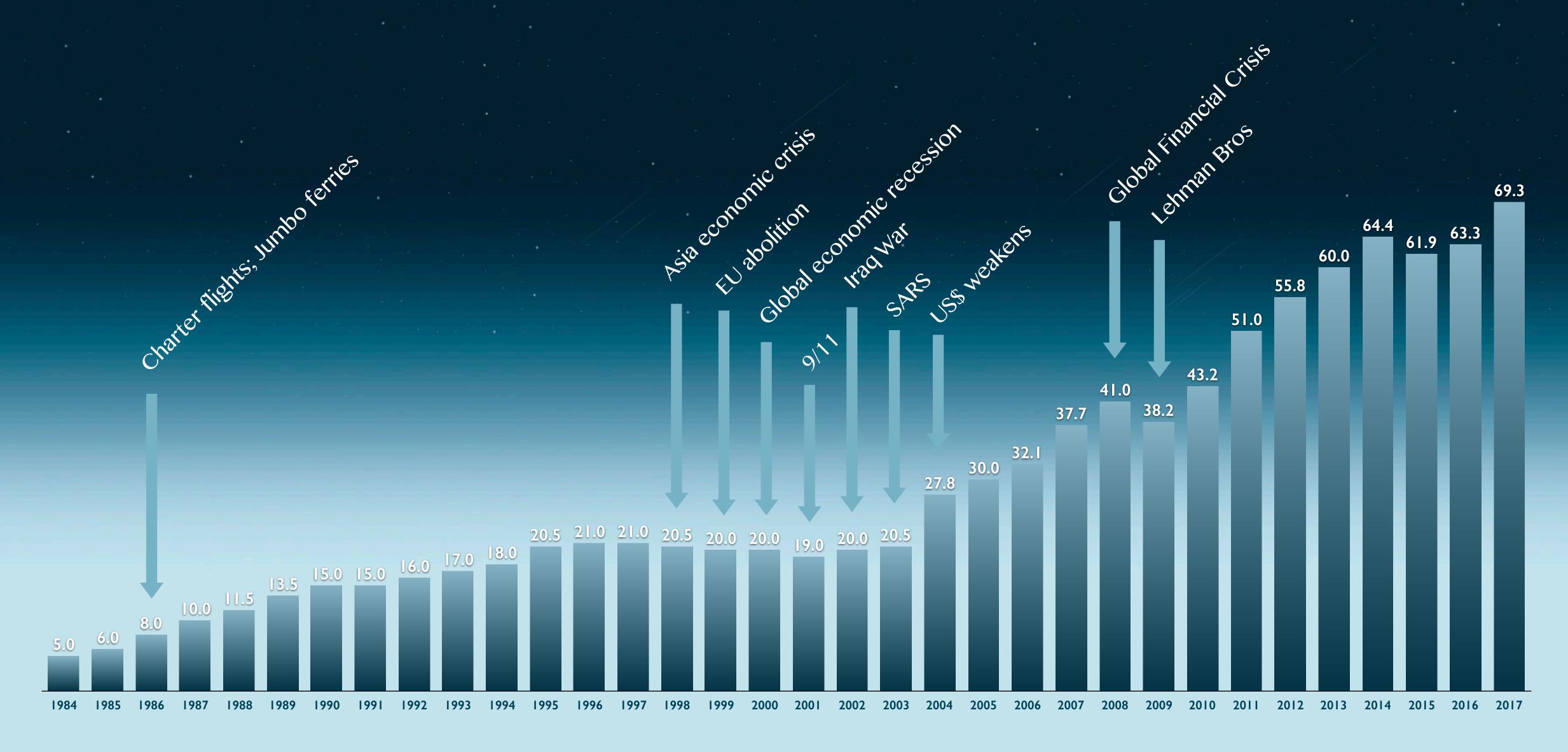


INTERNATIONAL TOURIST ARRIVALS

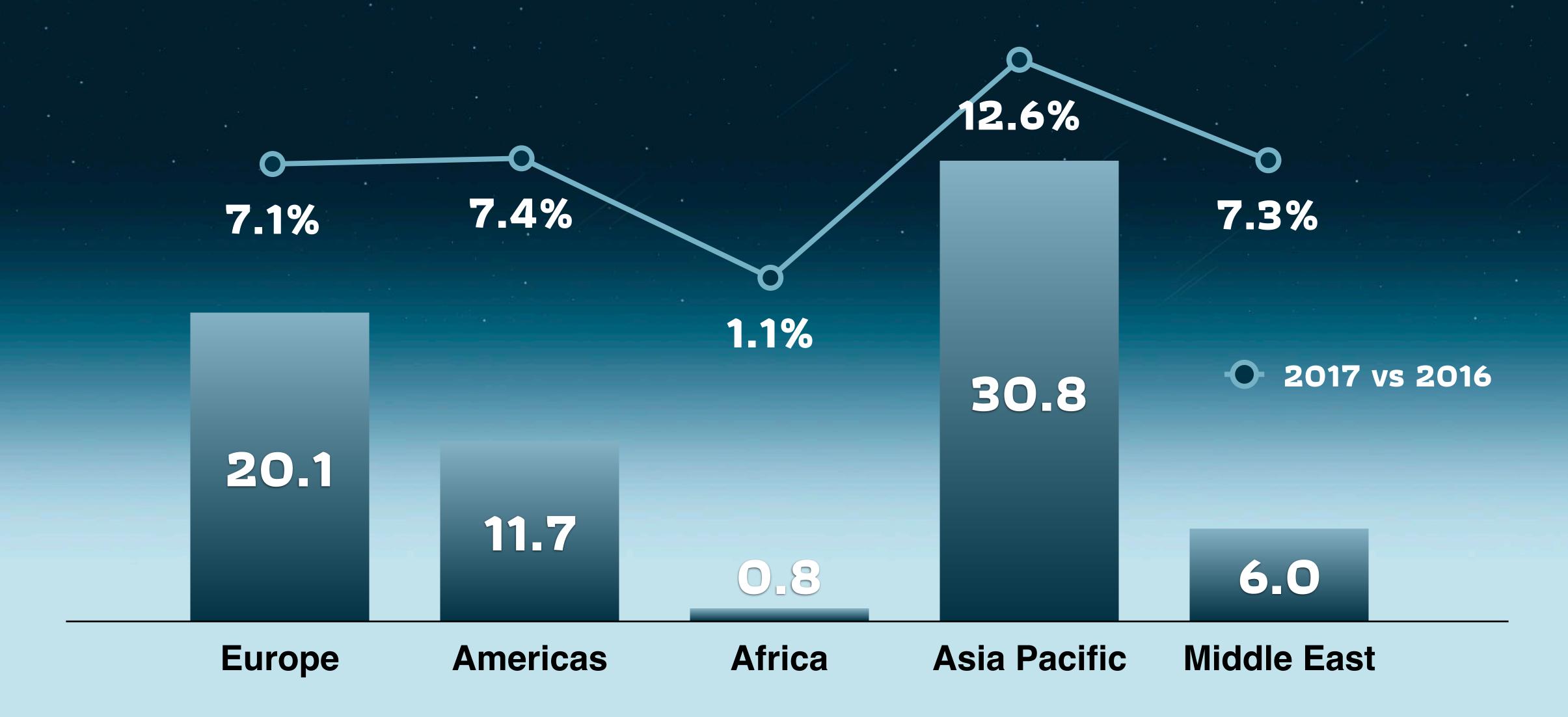

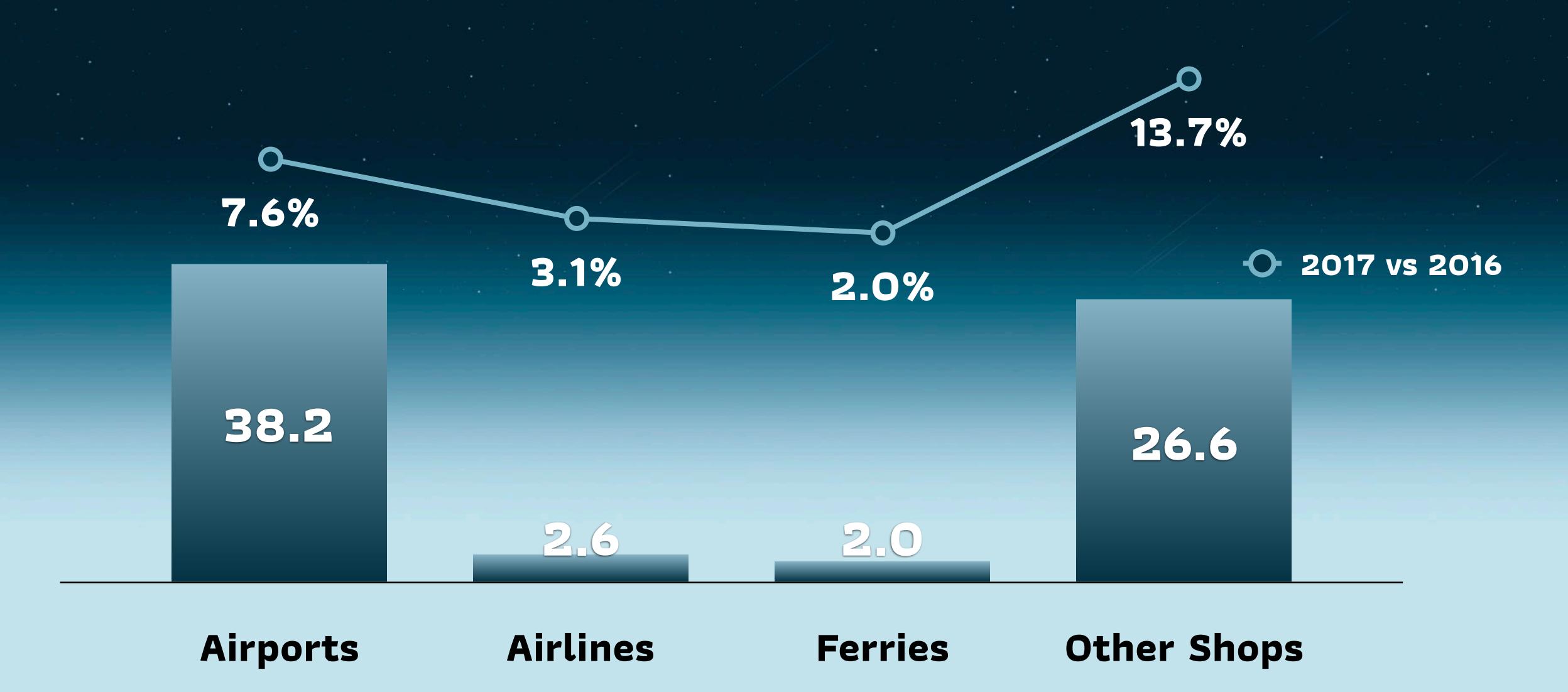

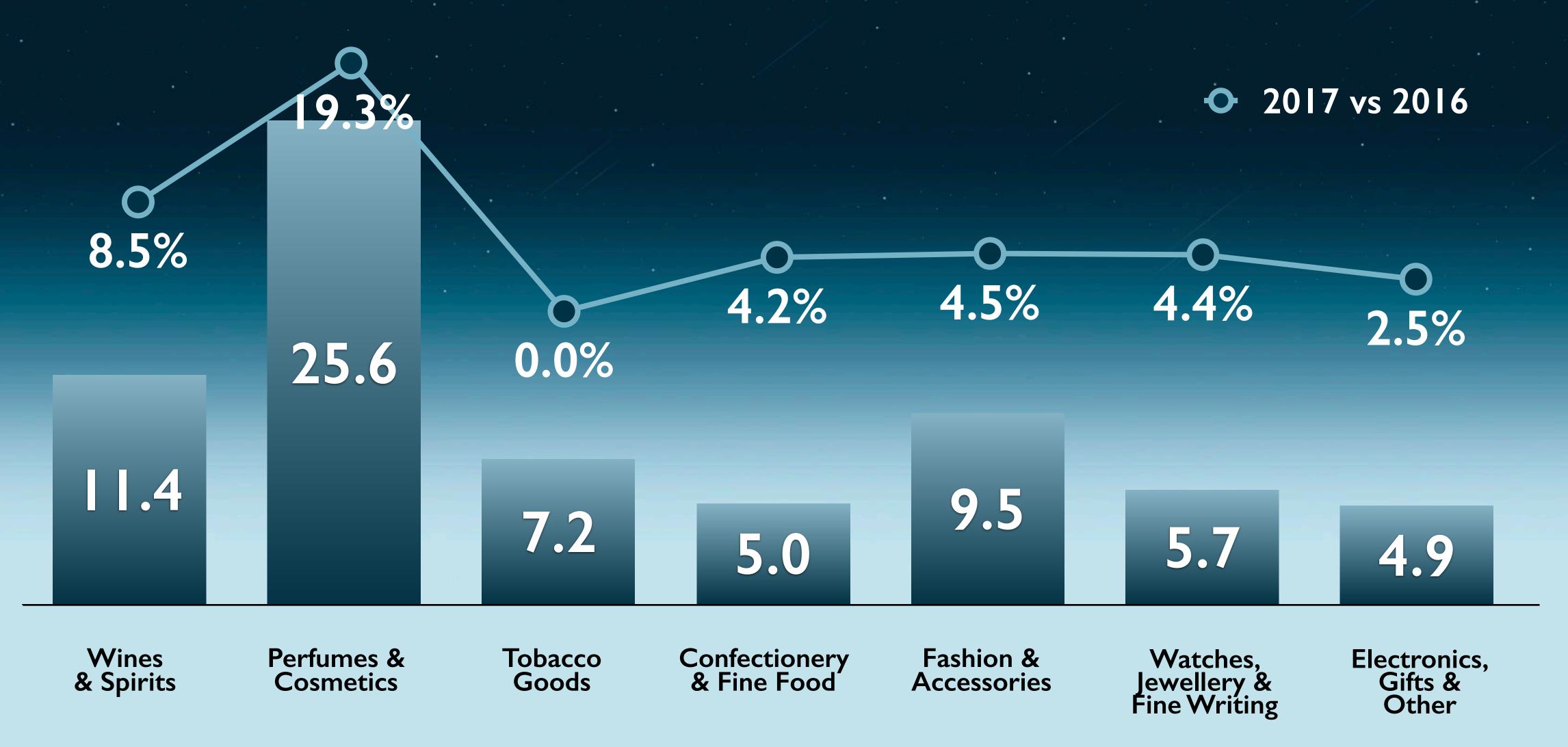

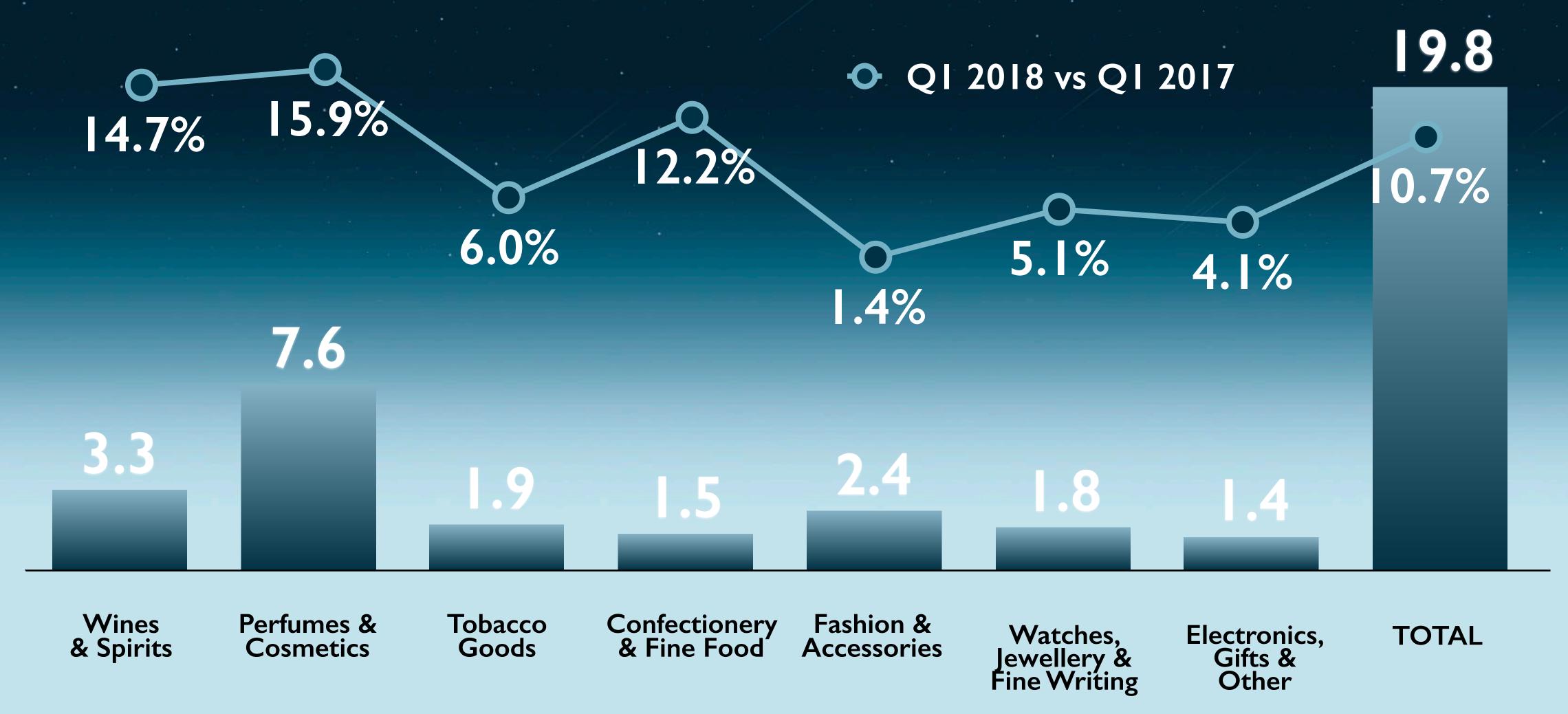
